Supreme Court Judgement

- Following the outcome of the Supreme Court judgement on 15th January 2021, direction has now been provided on a range of technical policy interpretations. This is believed to affect up to 370,000 businesses spread across 60 insurers and 700 different Business Interruption (BI) wordings in the market.
- While many policies will still not respond, the Court has delivered some radical judgements, widening the cover for many, and paving the way for increased settlements.
- With the judgement delivered, the FCA have imposed tight deadlines upon Insurers for communicating next steps with claimants and that process is now underway.
