## Case Study



# Crocodile CITES Conundrum



**Situation:** A rare and valuable crocodile Birkin handbag was damaged by a water leak, and the only restorer allowed by Hermès, the maker of the luxury handbag, was based in Paris.



**Scenario:** The secondary market for collectible accessories like handbags, shoes, and watches, is extremely strong as the supply of these items is limited. Bags like

the one involved in this loss have long waiting lists as there are only two produced globally each year. Restoration was needed but due to CITES (the Convention on International Trade in Endangered Species of Wild Fauna and Flora) regulations, protected materials such as crocodile skins need special certification and procedures for movement in and out of countries. Our adjusters organised the specialist transit of the handbag



to the restorer in Paris for repairs, as well as managing the logistics with Hermès to make sure the bag was repaired to the highest standard.

**Outcome:** The insured could rest easy knowing our adjusters were managing the restoration despite the legal restrictions and know that the financial value of the bag would be maintained through the official restoration of the exotic skin.
