Cleary & Associates merged with Adjusters Canada Inc. in 1995, where Bob continued his career at what merged into Crawford & Company (Canada) Inc., moving to Vancouver, British Columbia in 2000 to 2005 as Manager Technical Services, handling and/or supervising major Property and Boiler & Machinery losses across Canada and Internationally. Bob joined MGB Claims Consultants Inc. in 2019.

Bob has been involved in the adjustment of major property and business interruption losses, both domestic and global. Currently, Bob's focus has been on losses involving the auto parts manufacturing and mining industry, having been appointed as the control adjuster to Property Insurance Programs for a number of mining accounts and to a global auto parts manufacturing firm.
