# BIOGRAPHY

Michael began his adjusting career in Cardiff, UK in 1979 as a claims technician. He progressed to a property adjuster focusing on domestic and small commercial property claims in Brighton, UK and moved to London as a liability adjuster handling general property losses in the area then specialising in public, products, and employers' liability claims, mostly in south east England.

In 1990, he relocated to Thailand as a technical manager responsible for all losses handled by his office and a keen focus on construction and engineering claims as well as risk surveys in Bangkok and throughout Thailand. Michael moved back to London in 1993 as a senior home/foreign adjuster, travelling regularly to southern and eastern Europe and sub-Saharan Africa on civil engineering and infrastructure projects.
