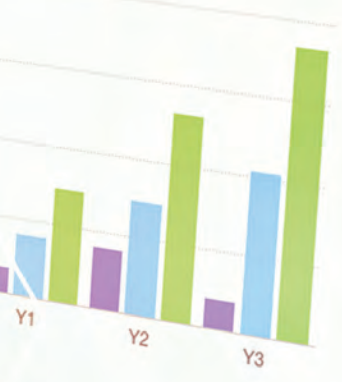

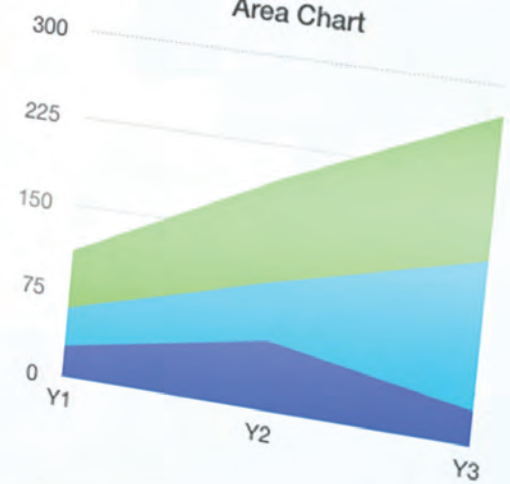
Column Chart

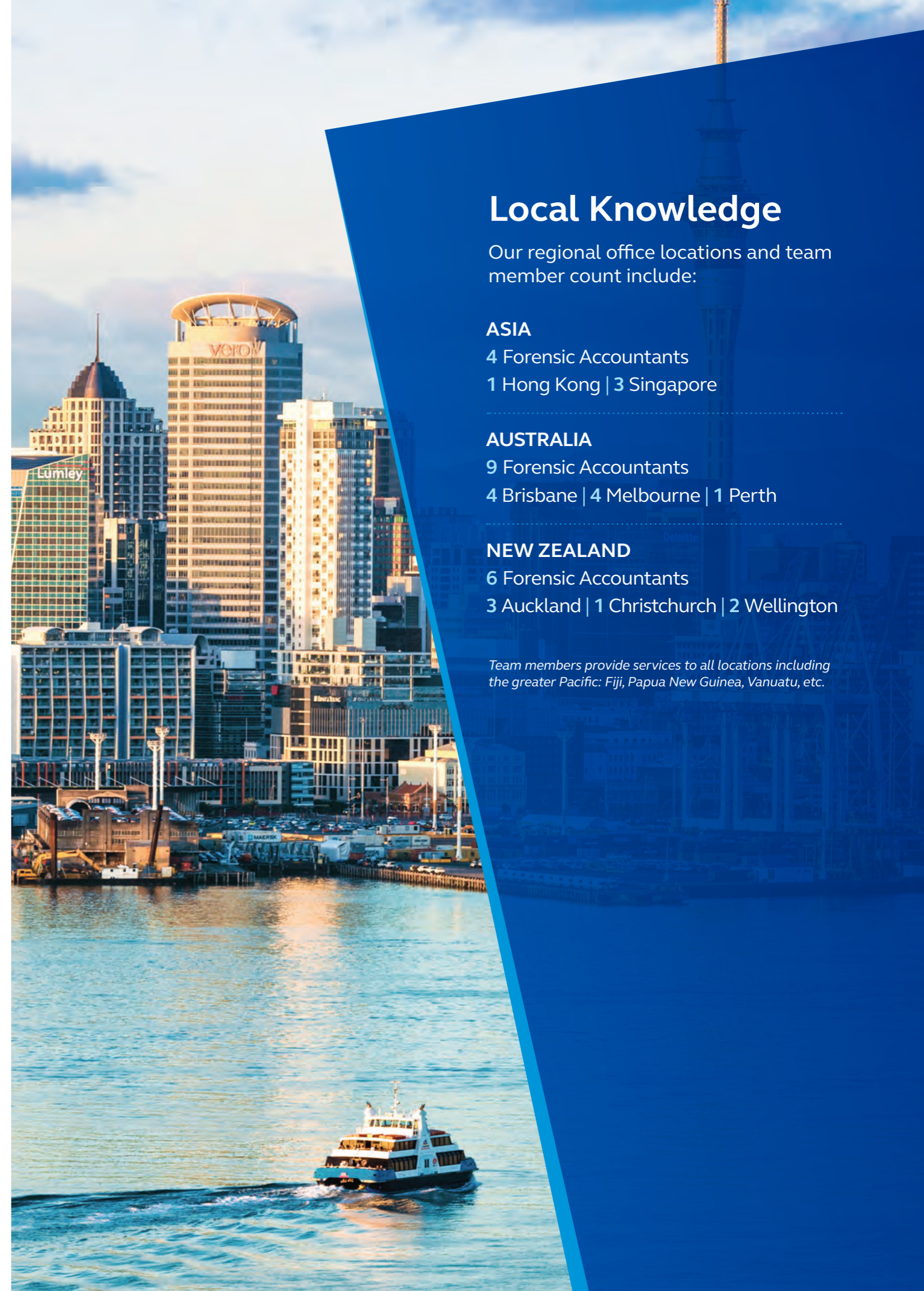
