#### **Update on Subs surge**

2025 has been a sunny year with the Met Office confirming we had the warmest Spring and Summer on record. This combined with rainfall well below average in the same period has resulted in exceptionally dry and shrunken ground in the clay areas of the UK. Whilst this is predominantly in the South-East, there are many other pockets of clay across the country.

With clay shrinkage subsidence accounting for around 60% of all UK subsidence, we are having a very busy Summer and Autumn for new subsidence claims. With volumes significantly increasing, the likelihood of reaching 4 x "business as usual" in September is quite likely, which is the traditional level when the market declares a surge situation.

Strategic planning and recruitment since the launch of our dedicated Subsidence Team in April means our capacity remains robust for enhanced new claim levels and WIP transfer which is occasionally requested by clients when our competitors are not performing.

#### **Hurricane Gabrielle Hits Spain**

On 30<sup>th</sup> September, the remnants of Hurricane Gabrielle triggered record rainfall and widespread flooding across eastern and Mediterranean Spain. The hardest-hit regions include Valencia, Catalonia, Aragón, Murcia, and the Balearic Islands (particularly Ibiza).

Rainfall totals surpassed 200 litres per square metre in some areas within a short time span, leading to rapid river overflows and flash floods. Infrastructure suffered significant disruption, with highways and local roads submerged or blocked, and rail and commuter services delayed or suspended.

Emergency services mounted large-scale rescue operations to evacuate residents and assist stranded motorists. Authorities urged the public to remain in safe locations and follow the instructions of Civil Protection and local emergency services.

Cleanup and recovery efforts are underway, focusing on restoring transport connections, pumping water from flooded zones, and assessing structural damage. The full extent of the losses and long-term impact is still being determined.
