He then became a General Adjuster for York Risk Services Group from 2012 to 2019 where he was responsible for the investigation, evaluation, negotiation, and resolution of property claims which are the most complex in coverage and represent the company's largest damage exposures.

Losses include Hospitality, Condominium, Apartment Complex, Commercial Risks, Large Industrial Properties, Churches, Retail Outlets, Inland Marine and Cargo, Builder's Risk, Products Liability, Premises Liability, slip/trip and fall, DRAM Shop/Liquor Liability, and Business Interruption.
